

Annex 2 to the Government Resolution of the Republic of Kazakhstan No. 802 dated December 15, 2016

List of exemptions for persons who do not require work permit

Foreigners and stateless persons:

1. Repatriated Kazakhs;

2. Business immigrants;

3. Granted the status of refugee or person, seeking asylum;

4. Immigrants granted humanitarian asylum in accordance with the Law of the Republic of Kazakhstan "On the Migration of the Population" dated July 22, 2011;

5. Sentenced by order of the courts of the Republic of Kazakhstan to imprisonment, suspended, for punishments not connected with isolation from society;

6. Victims of human trafficking during the period associated with a specific criminal trial connected with human trafficking, until the court's sentence is legally enforced;

7. Arriving in the Republic of Kazakhstan with the purpose of reuniting a family, of legal age, being a husband (or spouse) of a citizen of the Republic of Kazakhstan and being in a marriage recognized by the Republic of Kazakhstan for more than three years;

8. Studying full-time and simultaneously working at educational institutions in the Republic of Kazakhstan when not studying;

9. Who are citizens of the member-countries of the Agreement on Eurasian Economic Union dated May 29, 2014;

10. Crew members of sea and river vessels, air, rail, or motor transport;

11. Working as actors, stage directors, conductors, choirmasters, balletmasters, artists, tutors, sportsmen, coaches;

12. Attracted by the participants and authorities of the Astana International Financial Center;

13. Working as specialists in development of a space rocket system and maintenance of ground-based space infrastructure, hired under international agreements of the Republic of Kazakhstan on cooperation in aerospace industry;

14. Teaching in accordance with international agreements of the Republic of Kazakhstan on cooperation in the sphere of education at organizations of general secondary, technical, professional, secondary professional, and higher education of the Republic of Kazakhstan, but no more than 25% of the organization's staff, and



for realizing international integrated educational programs – no more than 50% of the organization's staff;

15. From amongst professional and teaching staff of higher education institutes to which a special privilege was granted according to the procedures established by the laws of the Republic of Kazakhstan, and working as working as managers and teachers with higher education with confirming documents according to the procedures established by the laws of the Republic of Kazakhstan and performing staff training for economic sector;

16. Working as chief executives of Branches or Representative offices of foreign legal entities, as well as by the first heads of Kazakhstan legal entities and their deputies with a 100% share of foreign participation in their authorized capital;

17. On business trip for business purposes duration of which does not exceed a total of one hundred twenty calendar days per calendar year;

18. Working as chief executives of organizations which have concluded contracts with the Government of the Republic of Kazakhstan for investment of more than 50 million US dollars, and chief executives of legal entities of the Republic of Kazakhstan performing investment activity in priority investment areas and concluded contract with the authorized body for investments.

19. Working in the national managing holding at positions not lower than heads of structural units with higher education with confirmed documents in the order established by the legislation of the Republic of Kazakhstan.

20. Involved to work as members of the board of directors of the national holding company.
